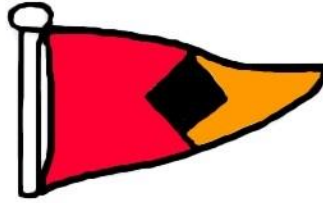

1. Only fully paid up members are allowed on the premises. (Provision has been made however for day visitors)
2. Membership stickers are to be clearly displayed on the boat.
3. Only one boat per member allowed. (Membership is not transferable between boats.)
4. No drinking and driving while on the waters.
5. Members may bring visitors to the club but will be held responsible for their actions at all times.
6. All boats to proceed in an anticlockwise direction at all times.
7. All boats must have life jackets, red flag and fire extinguisher and the required safety equipment as per the Vessels COF.
8. Inflatable vessels will wear life jackets at all times. (Rubber Ducks)
9. Clear hand signals must be given by Pilots at all times to indicate their intention.
10. The No wake Zone in front of the jetties must be adhered to all times for the protection of the moored boats and possible skiers.
11. Minimum age for a pilot is 16 years. All pilots must have a COC.
12. No more than three twin engine vessels to cruise on the water at the same time.
13. All boats towing skiers must have an observer in the boat at all times. other than the pilot. The observer's duty is to raise and lower the flag as a warning to other boats in the area that the skier is in the water. (M.O.B.) Skiers must give consideration to other boat users when dropping a ski. Skies are to be dropped as close as possible to the banks and out of the boating course.
14. Do not drive your vessel in the wake of a skier. (minimum distance is 100m)
15. When a boat has dropped off a skier in the drop off zone, he must stop, pull the ski rope in and proceed dead slow to the jetty.

16. All boats in the dam course have right of way.
17. The slipway must be cleared no later than 5 minutes after launching and all boats removed immediately from the slipway after loading. Boat preparation area is a NO Parking area. This area is only used to prepare boats for launching and removing/recovery.
18. No Boat may launch without a valid *COC* and *COF*.
19. All members and non members must sign the gate register and obtain a receipt from the Gate Manager for any monies paid over.
20. No PWCs (Jet skis) are allowed on this dam period and No Boat testing allowed on Saturdays and Sundays. Permission must be granted by management for any Jet Skis to be tested.
21. Boating times must be strictly adhered to at all times.

22. Any member or non members transgressing the Club rules will be asked to leave the premises immediately. The committee has the right to reprimand or cancel the membership should serious transgressions occur.
23. Members using Club facilities are requested to treat the facility as their own.
24. Children are the responsibility of parents at all times. Skiers and Children must wear Life Jackets at all times. Children making use of the swimming pool must be accompanied by an adult at all times. No Glasses to be brought into the pool area and No Braais allowed in the pool area.
25. All Members and Non members are to please respect the Home owners around the Dam with regard to voice and music control on the water.
